

**Don't Worry, He Won't Get Far On Foot Illustration Contest**  
**Official Rules**

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.**

1. **Sponsor:** Amazon Studios LLC, with an office at 9336 Washington Blvd, Culver City, CA 90232.
2. **CONTEST TIMING:** The *Don't Worry, He Won't Get Far On Foot* Illustration Contest (the "Contest") begins at 10:00 a.m. PST on 7/2/18 and ends at 11:59 p.m. PST on 7/12/18 (the "Contest Period").
3. **ELIGIBILITY:** Open to legal residents of the 50 U.S. and DC, 18 years or older as of date of entry. Employees of Amazon Studios LLC ("**Sponsor**") and its parent, subsidiaries, affiliates and their respective officers, directors, shareholders, members, employees, agents, assigns, and all others associated with the development, evolution and execution of this Contest (collectively "**Sponsor and its Administrators**") and the immediate family members of each, are not eligible to participate or win. All federal, state and local taxes are the sole responsibility of winners.
4. **HOW TO ENTER:** During the Contest Period, you may make a submission via the following ways:
  - a. a direct Facebook message to the Don't Worry, He Won't Get Far On Foot Official Facebook account;
  - b. uploading your submission to your Twitter or Instagram account and tagging it with #MyDontWorryCartoon; if submitting via Instagram, your profile must be public for the *Don't Worry, He Won't Get Far On Foot* account to view it.

Limit: One (1) Entry per person per Contest Period. All eligible entries must be received by end of the Contest Period to be eligible.

Only one account per user will be eligible; anyone found to be using multiple accounts to enter will be deemed ineligible. Potential winners may be required to show proof of being the authorized account holder of the email address/ account associated with the Entry.

Entrants account must be in good standing and submitted Entries must comply with each applicable Terms and Conditions to be eligible. Entrants may not copy the illustration from any source. Sponsor has the sole discretion to determine whether a submission qualifies as an Entry. Any Entry not in compliance with the above and which does not meet the requirements of these Official Rules will be disqualified. Any Entry or portion thereof that is, in the Sponsor's sole discretion, obscene, profane, lewd, defamatory, contains any third party materials, or otherwise violates or infringes (or may infringe) any copyright, trademark, logo, mark that identifies a brand or other proprietary right of any person living or deceased (including but not limited to rights of privacy or publicity or portrayal in a false light) or entity, or is otherwise objectionable or not in keeping with Sponsor's image, as determined in its sole discretion, will not be considered and may void all entries from the entrant. Entrants may not copy or otherwise plagiarize the illustration from any source. All entries must be the sole, original work of the entrants. Modifying, enhancing or altering a third party's pre-existing work does not qualify as

an original work. In such an event, any entrant engaged in such conduct will be disqualified from all portions of the Contest and all Entries from that entrant will be void for all portions of the Contest. Entrants and winners acknowledge and agree that their entries become the property of the Sponsor, which thereby has the right to edit, adapt, modify, reproduce, promote and otherwise use in any way it sees fit. Entrant grants to Sponsor and its designees the non-exclusive, irrevocable, perpetual, worldwide, royalty-free, transferable, sublicenseable right and license to use, perform, exhibit, reproduce and/or otherwise exploit his/her illustration in any manner and in any and all distribution channels, venues or media now known or hereafter devised, without further notice or any compensation to entrant. Entrant waives any "Moral Right of Authors" (*Droit Moral*) in the illustration. Entrant further agrees, upon Sponsor's request and without compensation, to sign any and all necessary and appropriate documents so as to effect, perfect or record such license rights. Normal Internet access, phone/usage charges imposed by your online/phone service will apply. By entering, you understand and agree that your Submission may (in Sponsor's sole discretion), 1) be posted online for consumers to view on the Sponsor's Social Media sites or other Sponsor-selected sites; and 2) be distributed across social media channels. Sponsor reserves the right to remove any posted Submissions, in its sole discretion, even if the Submission has already been made available to the public.

5. **WINNER DETERMINATION:** The Sponsor will judge all Entries received during the Contest Period, to determine the one (1) winner and judging will be conducted based on the following criteria: Use of a John Callahan illustrations as inspiration – 20%, Originality – 20%, Creativity – 20%, Imagination – 20%, and Artistic Merit – 20%. The one (1) Entry that receives the highest score will be deemed the prize winner. In the event of a tie, tied Entries will be re-judged based solely on: Use of John Callahan illustrations as inspiration – 100%. Judges' decisions are final on all matters related to this Contest.
6. **WINNER NOTIFICATION/PRIZE CLAIM:** Potential prize winners will be notified via "direct message" ("DM") on their account used at time of Entry within twenty-four (24) hours of winner selection, which will take place on the day immediately following the Contest Period. Potential winners will have to provide contact information, including a mailing address, and may be required to complete, sign and provide to Sponsor an Affidavit of Eligibility, Release of Liability/Prize Acceptance Form and a Publicity Release (except where prohibited by law) and Assignment of Rights in order to receive prize or prize will be forfeited and an alternate winner may be determined. If a prize notification DM or email is returned as undeliverable then the potential winner may be disqualified and an alternate winner may be determined. Prizes are nontransferable and no cash substitutions are allowed except by the Sponsor, who reserves the right to award a prize of equal or greater value if the advertised prize is unavailable. 7. **PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):** One (1) Prize: Winner will be sent a Don't Worry, He Won't Get Far On Foot prize pack including a printed original John Callahan illustration, a note from the Callahan Estate, a Don't Worry, He Won't Get Far On Foot poster and a copy of John Callahan's memoir with the new cover based on the film. ARV: \$100. Acceptance of a prize constitutes permission for the Sponsor and its agencies to use winner's name, photo and/or likeness and winner's Submission submitted in connection with this Contest for purposes of advertising and trade without further compensation, including a winners list,

unless prohibited by law. Prizes cannot be redeemed for cash. Any prize details not specified above will be determined by the Sponsor, in its sole discretion.

8. **GENERAL RULES:** By participating in the Contest, participants agree to be bound by these Official Rules and the decisions of the Sponsor. Sponsor and its Administrators are not responsible for technical, hardware, software or telephone malfunctions of any kind, lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications caused by the user or by any of the equipment or programming associated with or utilized in the Contest or by any human error which may occur in the processing of the Contest Entries. The Sponsor reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the Contest Entry process or the operation of the sites used for submission; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. Entries generated by script or bot are not eligible. In the event of a dispute as to the identity of a participant, the authorized account holder of the account submitted at the time of Entry will be deemed to be the participant. "Authorized account holder" of an account is defined as the person who is responsible for joining the site and who manages the e-mail address associated with the account. The Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend the Contest if it is not capable of running as planned, including, but not limited to, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures or any other problems beyond the control of the Sponsor and award applicable Prizes from among all eligible Entries received per Entry Period prior to cancellation, if any. Prize winners and all entrants, as a condition of Entry into the Contest, agree to release and hold harmless Sponsor and its Administrators and each of their respective affiliates, officers, directors, agents, and employees will have no liability or responsibility for any claim arising in connection with participation in the Contest or Prizes awarded. Void where prohibited and subject to all federal, state and local laws. As a condition of entering the Contest, agrees that: 1) under no circumstance will participant be permitted to obtain awards for, and participant hereby waives all rights to claim, punitive, incidental, consequential or any other damages, other than for out-of-pocket expenses; 2) all causes of action arising out of or connected with the Contest or the Prize awarded, shall be resolved individually, without resort to any form of class action; and 3) any and all claims, judgments, and award shall be limited to actual out-of-pocket costs incurred, but in no event, attorneys' fees. You hereby represent and warrant that you have read these Official Rules and are fully familiar with its contents. Winners and all entrants, as a condition of Entry into the Contest, agree to release and forever discharge, covenant not to sue, and hold harmless Sponsor and its Administrators and each of their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies and their respective officers, directors, shareholders, members, employees, agents, assigns, and all others associated with the development, evolvment and execution of the Contest from and against any and all liability, claims or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with submitting an Entry or otherwise participating in any aspect of the Contest, the receipt, ownership or use of the prizes awarded, or any typographical or other error in these Official Rules or the announcement or offering of the prizes.
