

**Find your SERENITY Sweepstakes**  
Official Rules

The Find your SERENITY Sweepstakes (the "Sweepstakes") starts at 10:00 a.m. Eastern Time ("ET") on January 3, 2019 and ends at 11:59 p.m. PT on January 23, 2019 ("Sweepstakes Period"). Entries not received within the Sweepstakes Period will be void.

**ELIGIBILITY:** Sweepstakes is open to legal residents of the continental United States and the District of Columbia (excluding residents of Alaska, Hawaii, Puerto Rico and any/all U.S. territories and possessions), who are 21 years of age or older.
