INTRODUCTION:

By visiting this website or otherwise interacting with Screen Media Ventures, LLC you agree that you have read this Policy and agree to SCREEN MEDIA VENTURES, LLC’s processing of your personal data in accordance with this Policy.

TYPES OF INFORMATION SCREEN MEDIA VENTURES, LLC COLLECTS:

SCREEN MEDIA VENTURES, LLC collects two basic types of information personal information and anonymous information, and may use personal information to create a third type of information aggregate information:

Information you provide:

Registration information you provide when you sign up for mailing lists, including: your name; email address; city, town, county and country, of residence;

Information you expressly provide when you use this website, or SCREEN MEDIA VENTURES, LLC's applications on third-party sites or platforms such as social networking sites;

Information you provide by visiting this website or a, and where applicable, consenting to the use of Cookies during such visit. Such information may include:

User Client ID generated by Cookies which are unique to you;

Referrer information (e.g. location of link you clicked to reach our page);

Campaign tag information (e.g. hashtags);

User Agent information (e.g. browser type);

IP Address;

Country and City location data (based on IP); and

Information provided by individuals in the course of business (such as e-mail addresses, financial information from Cinema's and Sub-Distributors booking content through us); and

Location information when you visit this website, including location information provided by a mobile device interacting with this site, your IP address, device information, browser type, referral source, length of visit, operating system, number of page views, when you open emails SCREEN MEDIA VENTURES, LLC sends, or other similar information which SCREEN MEDIA VENTURES, LLC is permitted by law to process.

Information received from third parties:

However, to ensure that we always have the most up to date consent and accurate data from you, SCREEN MEDIA VENTURES, LLC will contact you by e-mail to seek renewed consent at least once during a specified time period depending on the type of Content we are contacting you about and how frequently we are able predict future releases of similar content, as follows:

if you subscribed to hear more about our Opera, Ballet & Theatre Content (including Musical Theatre), we will contact you every two (2) years;

If you subscribed to hear more about our Music Performance (i.e. Live Concerts/Gigs) Releases, Motion-Picture or Documentary Films or any other type of Content which we've not listed here, we will contact you every five (5) years;

These e-mail communications will ask you to expressly re-subscribe and provide your current details. If you do not respond, we will assume that you no longer wish to hear from us and will remove you from the mailing list until such time as you actively re-subscribe.

WHERE YOUR INFORMATION IS STORED:

SCREEN MEDIA VENTURES, LLC's servers are situated in the European Economic Area (predominately the UK and Ireland) and all of the information that we collect about you will be stored on these servers.

Unless required by any specific law or regulation, we will not share your information outside of the European Economic Area without your explicit consent.

YOUR RIGHTS, CONTROLS AND CHOICES:
